# TORRENS UNIVERSITY AUSTRALIA AND PENRITH PANTHERS COMPETITION GAME OF SKILL TERMS AND CONDITIONS

This competition is delivered by Torrens University Australia Limited (ABN 99 154 937 005) of Level 24, 680 George Street, Sydney, NSW, 2000, in conjunction with Penrith Panthers District Rugby League Club (ABN 28 003 908 503) of 123 Mulgoa Road, Penrith, NSW, 2750 (together the "**PROMOTER**").

By entering this competition, you, the Applicant ("Applicant"), agree to the following terms and conditions:

## **Application**

- 1. Information on how to enter forms part of these Terms and Conditions.
- 2. The directors, management and employees (and their immediate families) of the PROMOTER, its related entities, printers, suppliers, providers and agencies whom are directly associated with the conduct of this competition are ineligible to enter the competition. The successful Applicant will be notified by email that was supplied upon entry after the final decision of the PROMOTER on the 19 May 2021 and will be announced via email once the successful Applicant has responded to acknowledge their acceptance of the prize offer. All reasonable steps to notify the successful Applicant of the result of the draw will be taken by the PROMOTER. The PROMOTER'S decision is final and no correspondence will be entered into.

#### **Prize**
